

Foster Care and Adoption Assistance—CBO’s May 2019 Baseline

Foster care and permanency programs are open-ended entitlement programs that provide partial reimbursements to states for the cost of providing foster care, adoption assistance, and kinship guardian assistance to children who meet certain federal eligibility criteria. Each state is reimbursed for direct financial assistance according to a formula—based on the state’s federal medical assistance percentage rate—which can range from 50 percent to 83 percent of the state’s cost per child. Administrative and training costs associated with foster care and permanency programs are reimbursed at 50 percent and 75 percent, respectively, for all states. About 60 percent of the amount in federal payments to states is for spending associated with support for foster care.
