## REPORT ON UNAUTHORIZED APPROPRIATIONS AND EXPIRING AUTHORIZATIONS

The Balanced Budget and Emergency Deficit Control Act of 1985 (Public Law 99-177) requires the Congressional Budget Office (CBO) to report to the Congress on unauthorized appropriations and expiring authorizations. Section 221(b) of the Act added this requirement to Section 202(f) of the Congressional Budget and Impoundment Control Act of 1974, as amended:

"(3) On or before January 15 of each year, the Director, after consultation with the appropriate committees of the House and the Senate, shall submit to the Congress a report listing (A) all programs and activities funded during the fiscal year ending September 30 of that calendar year for which authorizations for appropriations have not been enacted for that fiscal year, and (B) all programs and activities for which no authorizations for appropriations have been enacted for the fiscal year beginning October 1 of that calendar year."

The new requirement expanded functions CBO had performed at the request of the Budget Committees for a number of years. The conference report on the Balanced Budget Act states that the purpose of the requirement is "to help Congress use the early months of the year to adopt authorizing legislation that must be in place before the thirteen regular appropriation bills can be considered."

The body of this report consists of two appendices listing unauthorized FY 1987 appropriations and authorizations that will expire by the end of FY 1988. The listings include data on all public laws enacted during the Second Session of the 99th Congress.

APPENDIX A: SUMMARY OF FISCAL YEAR 1987 APPROPRIATIONS FOR PROGRAMS AND ACTIVITIES WITH EXPIRED OR INSUFFICIENT AUTHORIZATIONS

Appendix A combines data from CBO's Legislative Classification System (LCS) and current level estimates for FY 1987. CBO uses the LCS to compile and update information on the authorizing laws for each budget account as well as the House and Senate committees that originated and have jurisdiction over those statutes. The LCS contains data on individual provisions of law that authorize government programs and activities, but does not include information on individual projects, which usually are smaller in scope and cost than programs or activities and often do not have specific statutory authorizations. CBO's current level estimates, in contrast, are at the level of individual budget accounts, which frequently include funding for numerous programs, activities, or projects.

The format of Appendix A reflects the difference in the levels of detail provided by the two types of data. Information on expired or insufficient authorizations of appropriations for programs and activities that have been funded in FY 1987 is listed by appropriation account beneath the current FY 1987 appropriation for each account. Most of the provisions authorized appropriations before FY 1987 and thus have expired; some authorize less money for FY 1987 than has been appropriated. A key to the listing has been provided to assist the reader.

In some instances, an appropriation funds more than one program or activity and the legislative history indicates that Congress intended to provide a specific sum for particular programs funded by the appropriation. In those cases, CBO has compared that sum with any amount authorized to be appropriated for the item in FY 1987 to determine if any of the funds were provided without authorization. If so, information on the insufficient authorization of FY 1987 funding for the particular program is displayed.

Tables 1 and 2 organize the amounts appropriated in FY 1987 for programs and activities with expired or insufficient authorizations of appropriations by House and Senate authorizing committees, respectively. For programs and activities that lack FY 1987 authorizations of appropriations, the amounts include the total FY 1987 appropriation. Where the FY 1987 appropriation for a program or activity exceeds the amount(s) authorized to be appropriated, the figures include the excess amount.

APPENDIX B: SUMMARY OF AUTHORIZATIONS WITH BUDGETARY IMPACT EXPIRING BETWEEN JANUARY 1, 1987 AND SEPTEMBER 30, 1988

Appendix B lists provisions of law with budgetary impact that will expire between January 1, 1987 and September 30, 1988. For each provision that authorizes appropriations, the listing indicates the authorized funding level for each fiscal year. Other types of expiring authorizations listed include:

- o Organic authorizations (including spending authority defined by Section 402(c)(2)(A) of the Congressional Budget Act);
- o Credit authorizations--grants of authority to make direct loans or to guarantee or insure the indebtedness of others; and
- o Contract authority (as defined by Section 402(c)(2)(A) of the Budget Act).

A key to the listing in Appendix B has been provided to assist the reader.

Tables 3 through 6 provide aggregate information on the expiring provisions of law listed in Appendix B. Table 3 summarize the expiring provisions by type of authorization. Tables 4 and 5 summarizes the expiring authorizations of appropriations by House and Senate authorizing committees, respectively. Shown for each committee are the number of authorizations, and the total appropriations authorized by those provisions, which will expire by the end of fiscal years 1987 and 1988. Table 6 lists the laws which will expire by the end of FY 1987 and which authorize FY 1987 appropriations greater than \$100 million.
