

CBO's Recent Publications and Work in Progress as of March 31, 2024

April 2024

To provide the Congress with a comprehensive review of its work, the Congressional Budget Office publishes quarterly reports that highlight the agency's recent publications and summarize its work in progress.¹ Over the past three months, CBO has produced a variety of budgetary and economic analyses, fulfilling the agency's core mission of supporting the Congress during each stage of the legislative process. The agency's work takes many forms, including technical assistance, cost estimates, testimonies, reports, and other analytic products.

Recent Cost Estimates

CBO routinely provides the Congress with information about the effects of proposed legislation on the federal budget through its technical assistance and cost estimates. The agency is required by law to prepare a cost estimate for nearly every bill that is approved by a full Congressional committee of the House of Representatives or the Senate.² It also publishes cost estimates at other stages of the legislative process if requested to do so by a relevant committee or by Congressional leadership. In addition, CBO reviews bills scheduled to be considered under suspension of the rules in the House.

This past quarter, the agency published 245 cost estimates, including these:

- A cost estimate for the Consolidated Appropriations Act, 2024 (Public Law 118-42), and a cost estimate for the Further Consolidated Appropriations Act, 2024 (P.L. 118-47), which mainly provide discretionary appropriations and authorities for the remainder of fiscal year 2024; and
- A cost estimate for S. 2840, the Bipartisan Primary Care and Health Workforce Act, which includes provisions related to access to and quality of primary health care, expanding the health workforce, and reducing the costs of private health insurance.

Recent Analytic Products

In addition to cost estimates, CBO has released 24 testimonies, reports, and other analytic products since publishing its most recent quarterly report on the agency's work in progress (see Table 1 on page 6).

Some of those products provided an analysis of or information related to the nation's budgetary and economic situation:

- A recurring report, testimony, and slide deck describing CBO's budgetary and economic projections from 2024 to 2034;
- A recurring report presenting CBO's projections of what the federal budget and the economy would look like over the next 30 years if current laws generally remained unchanged;
- A recurring visual report describing CBO's demographic projections over the next three decades;
- A set of four infographics examining revenues and outlays recorded in fiscal year 2023;
- Testimony on the accuracy of the agency's recent baseline projections;
- A summary of legislation enacted in the first session of the 118th Congress that affects mandatory spending or revenues; and
- A recurring report on expired and expiring authorizations of appropriations for fiscal year 2024, covering legislation enacted through September 30, 2023.

The agency also published three interactive tools:

- A waterfall model that allows users to simulate CBO's process for projecting discretionary budget authority and outlays for different types of spending;
- A workbook that allows users to see how revenues and outlays that differed from those in CBO's February 2024 baseline budget projections would affect debt-service costs, deficits, and debt; and
- A tool that allows users to explore the effects of policies that would increase the federal minimum wage.

In addition, each month since the previous update on the agency's work in progress, CBO issued its *Monthly Budget Review* of federal spending and revenues for the preceding month and the fiscal year to date. CBO also published its appropriation request for fiscal year 2025.

Three publications explored topics in the areas of national security, the environment, and health care, respectively:

- A report comparing the housing standards used to determine the military's basic allowance for housing with the housing rented by comparable civilians;
- A visual report providing information about trends in greenhouse gas emissions in the manufacturing sector; and
- Testimony on federal subsidies for health insurance and policies to reduce the prices paid by commercial insurers.

Three publications explained analytic methods that CBO uses in its work or provided background information about that work:

- A report describing the role of Federal Home Loan Banks (a government-sponsored enterprise) in financial markets and estimating the value of the federal subsidies they receive;
- A report describing how funding for the Internal Revenue Service affects CBO's revenue projections and how CBO estimates the revenue effects of rescissions of such funding; and
- A working paper explaining how CBO projects consumer price inflation.

CBO also responded to questions from Members of Congress in these publications:

- A letter about CBO's timeline for providing a cost estimate for H.R. 1770, the Equitable Community Access to Pharmacist Services Act;
- Answers to questions for the record following a hearing on *The Budget and Economic Outlook:* 2024 to 2034;
- Answers to questions for the record following a hearing on health care spending;
- Answers to questions for the record following a hearing on the oversight of CBO;
- A letter responding to a question about what the effects on federal deficits would be if the economy was stagnant for two years;
- A letter providing information regarding CBO's engagement with the AbilityOne program, which promotes the procurement of products and services supplied by nonprofit organizations that employ people who are blind or have significant disabilities; and
- A letter and a subsequent update about implementing the caps on most discretionary funding for fiscal year 2024 as established by the Fiscal Responsibility Act of 2023.

In addition, CBO updated a report providing an overview of the agency and describing its work for the Congress. And CBO posted various presentations on its website that were given by the agency's staff.

Work in Progress

As of March 31, 2024, CBO was preparing 231 cost estimates, nearly all of which are for legislation that has been approved by a committee (see Table 2 on page 7). The agency was also working on 33 analytic products that it expected to complete in the coming months.

Nine recurring reports were in progress as of March 31:

- Final Sequestration Report for Fiscal Year 2024 (released on April 5);
- The *Monthly Budget Review: March 2024* (released on April 8);
- Transparency at CBO: Plans for 2024 and a Review of 2023 (to be released on April 24);
- Budgetary Outcomes Under Alternative Assumptions About Spending and Revenues (to be released in early May);

- The Long-Term Budget Outlook Under Alternative Scenarios for the Economy and the Budget (to be released in late spring);
- An Update to the Budget Outlook: 2024 to 2034 (to be released in late spring);
- An Analysis of the Discretionary Spending Proposals in the President's 2025 Budget (to be released in early summer);
- Estimates of the Cost of Federal Credit Programs in 2025 (to be released in early summer); and
- *Options for Reducing the Deficit:* 2025 to 2034 (to be released in late 2024).

Thirteen requested products were in progress as of March 31:

- A visual report about student loan repayment;
- A report describing CBO's approach to analyzing policies that would increase Medicare's coverage of treatments for obesity;
- A report assessing alternative approaches to reducing prescription drug prices;
- A report summarizing recent research findings on Medicare accountable care organizations and the factors that have contributed to or limited their budgetary savings;
- A report examining the income of Black veterans who served during the Gulf War era;
- A report estimating the acquisition costs of the Navy's medium landing ship (released on April 11);
- Testimony summarizing CBO's estimates of the cost of the Coast Guard's Polar Security Cutter:
- A report summarizing the risks that climate change poses to the federal budget and the economy;
- A report about the effects of immigration on CBO's baseline budget projections;
- An update to a report analyzing how inflation has affected households at different income levels since 2019;
- A visual report presenting the distribution of household income, means-tested transfers, and federal taxes in 2021, along with a companion document examining the associated trends from 1979 through 2021;
- A report comparing the cost of compensation for federal civilian employees with that of employees in the private sector; and
- A report describing the distribution of family wealth.

Also in progress as of March 31 was a report (released on April 11) comparing rates of economywide inflation with rates of change in the Navy's shipbuilding composite index, which the service uses to assess the growth of costs in the naval shipbuilding industry.

CBO has many other products in the research, drafting, and editing stages that support its mission to provide the Congress with timely analyses of policy issues. One such report will assess the distribution of flood insurance coverage by income and by demographic and other characteristics.

Three publications will assess the budgetary and economic effects from flood damage:

- A working paper analyzing the budgetary effects of the risk from floods to homes with federally backed mortgages;
- A report summarizing the amount of flood damage avoided by federal spending on climate adaptation; and
- A working paper describing how CBO models the damage avoided from selected types of spending on flood adaptation.

Two publications will provide analyses of energy and environmental issues:

- A report evaluating the effects of climate change on markets for property and casualty insurance; and
- A working paper describing CBO's approach to modeling the effects of various policies in the electric power sector.

A visual report will also describe trends in the distribution of rebates paid by pharmaceutical manufacturers in the Medicare Part D program.

Several products were in progress as of March 31 that explain analytic methods that CBO uses in its work or that provide background information about that work:

- A report about risk sharing in federal credit programs;
- A report describing how CBO selects and uses discount rates in its analyses; and
- An interactive workbook that allows users to define and analyze economic scenarios by specifying differences in the values of certain economic variables relative to the values underlying CBO's February 2024 baseline projections (released on April 9).

CBO's published reports and a list of upcoming releases are available on the agency's website.

The Congressional Budget Office prepares this report each quarter to help keep the Congress informed about the agency's work.
